RULES AND REGULATIONS

- Bengal Tax Counsel reserves the right to reject any application for admission without assigning any reason whatsoever.
- 2. Fees are payable in advance at the time of admission unless the payment by installments is preferred. Fees paid either in full or in part, shall not be refunded under any circumstances. In case of payment by installment fees must be paid within 15th of each month. A fine of Rs. 2.00 per day shall be imposed for any default their after. In case of a cheque being dishonoured / return an extra charge of Rs. 250.00 per cheque shall be borne by the candidate.
- 3. Couse Duration: Although the Duration for PCAT Course is fixed for 1 Year, it may be extended if situation demands. Such extension shall be decided solely by the Institute at its own discretion, which shall be final and binding on the student.
- 4. Eligibility: 1) B.Com and Law Graduate Direct Admission, 2) Other Graduates: Solely at the discreation of the Institute.
- 5. A Candidate desirous to change combination of days for any reason will have to pay a Transfer Fee of Rs. 2,500/- in addition to the fees payable for the remaining period of changed Batch.
- 6. No alternative arrangement will be made for candidates unable to attend classes.
- 7. The timings of classes can be altered by the Institute for administrative reasons.
- 8. Willful damage or damage due to sheer negligence to computers or any other property of the Institute by a student will have to be compensated in full by such student.
- 9. During any course in session Bengal Tax Counsel Educare reserves the right to expel any student for indiscipline, non payment of fees, non-attendance of classes or any other reason which, the Administrator of the Institute found not conducive for either the Institute or fellow students. In case of such expulsion there shall not be any refund of fees already paid either in part or in full.
- 10. The study material provided by the Institute is not to be reproduced in any form without written permission from the Administrator of the Institute.
